The undersigned is informed and believes that:

COUNT 1

On or between December 1, 2009 and December 31, 2009, in the County of Mono, the crime of LEWD ACT UPON A CHILD, in violation of **PENAL CODE SECTION 288(c)(1)**, a Felony, was committed by JOSEPH THOMAS WALKER, who did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body of JANE DOE, DOB: 10/19/95, who was FOURTEEN years old, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the defendant, who was at least 10 years older than victim., to wit: Defendant sexually touched and kissed JANE DOE, DOB: 10/19/95 for first time while Jane Doe was on her winter break in Mammoth Lakes.

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.67**.

"NOTICE: Conviction of this offense will require you to register pursuant to **Penal Code Section 290**. Willful failure to register is a crime."

On or between December 1, 2009 and December 31, 2009, in the County of Mono, the crime of LEWD ACT UPON A CHILD, in violation of **PENAL CODE SECTION 288(c)(1)**, a Felony, was committed by JOSEPH THOMAS WALKER, who did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body of JANE DOE, DOB: 10/19/95, who was FOURTEEN years old, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the defendant, who was at least 10 years older than victim, to wit: Defendant touched JANE DOE, DOB: 10/19/95, after removing her pants, in Mammoth Lakes.

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.67**.

On or between January 2, 2010 and January 5, 2010, in the County of Mono, the crime of LEWD ACT UPON A CHILD, in violation of **PENAL CODE SECTION 288(c)(1)**, a Felony, was committed by JOSEPH THOMAS WALKER, who did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body of JANE DOE, DOB: 10/19/95, who was FOURTEEN years old, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the defendant, who was at least 10 years older than victim, to wit: Defendant and JANE DOE, DOB: 10/19/95, had sexual intercourse for the first time at the residence of defendant’s parents, in Mammoth Lakes.

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.67**.

Said acts occurred at the residence of defendant's parents, in Mammoth Lakes.

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.67**.

"NOTICE: Pursuant to the provisions of **Penal Code Section 293.5** the use of pseudonym "Jane or John Doe", if it appears in the complaint or information, is for purposes of protecting the privacy of the alleged victim."

COUNT 5

On or between January 1, 2010 and May 31, 2010, in the County of Mono, the crime of LEWD ACT UPON A CHILD, in violation of **PENAL CODE SECTION 288(c)(1)**, a Felony, was committed by JOSEPH THOMAS WALKER, who did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body of JANE DOE, DOB: 10/19/95, who was FOURTEEN years old, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the defendant, who was at least 10 years older than victim, to wit: The second time defendant had sexual intercourse with JANE DOE, DOB: 10/19/95, at the residence of defendant's parents, in Mammoth Lakes.

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.67**.

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.67**.

COUNT 9

On or between January 1, 2010 and August 31, 2011, in the County of Santa Barbara, the crime of CONSPIRACY TO COMMIT A CRIME, in violation of **PENAL CODE SECTION 182(a)(1)**, a Felony, was committed by JOSEPH THOMAS WALKER, who did unlawfully conspire together and with another person and persons whose identity is unknown to commit the crime of LEWD ACT UPON A CHILD, in violation of Section PC288(c)(1), of the Penal Code, a Felony and that pursuant to and for the purpose of carrying out the objects and purposes of the aforesaid conspiracy, the said defendant(s) committed the following overt act and acts at and in the Counties of Mono and Santa Barbara:

OVERT ACT 1

Defendant encouraged JANE DOE to have sexual relations with ANDREW BOURNE. Defendant stated to JANE DOE, DOB: 10/19/95, "We can't tell [BOURNE] about us until after you're with him or he won't understand and he'll judge me....Once you've been with him, then I won't be alone in this."

OVERT ACT 2

Defendant encouraged ANDREW BOURNE to become physical sexually with JANE DOE, DOB: 10/19/95 after Defendant had sexual intercourse with JANE DOE multiple times starting in January 2010. Defendant told ANDREW BOURNE, "Something like this happens once in a lifetime,...and you need to take it to the next level...you need to get physical with JANE DOE." ANDREW BOURNE told DETECTIVE HUNTER that part of the reason he [BOURNE] became physical with JANE DOE was because defendant encouraged him to.

OVERT ACT 3

JANE DOE, DOB: 10/19/95, had sexual intercourse with ANDREW BOURNE for the first time in late June 2010 in Mono County after Defendant encouraged her to do so.

OVERT ACT 4

JANE DOE, DOB: 10/19/95, had sexual intercourse with ANDREW BOURNE on five additional occasions in Mono County between July and October, 2010, after Defendant encouraged her to do so.

OVERT ACT 5

On January 21, 2011, Defendant emailed JANE DOE, DOB: 10/19/95, "I pray that I won't lose your friendship. I promise I will be supportive in your endeavors, even if it's continuing the physical with [BOURNE]..."

OVERT ACT 6

On May 9, 2011, Defendant spoke with ANDREW BOURNE and suggested hiring JANE DOE, DOB: 10/19/95, as a nanny for the summer, in Mammoth Lakes.

OVERT ACT 7

On July 2, 2011, JANE DOE, DOB: 10/19/95, emailed Defendant and stated, "You told me I should be with [BOURNE]. You told me to."

COUNT 10

On or about October 3, 2010, in the County of Santa Barbara, the crime of UNLAWFUL CONTACT WITH A CHILD WITH INTENT TO COMMIT A SEXUAL CRIME, in violation of **PENAL CODE SECTION 288.3**, a Felony, was committed by JOSEPH THOMAS WALKER, who did willfully and unlawfully contact or communicate with a minor, JANE DOE, DOB: 10/19/95, who knows or reasonably should know the person is a minor, with intent to commit Penal Code section 288(c)(1) – LEWD ACT ON A CHILD AGED 14 OR 15 YEARS OLD.

“NOTICE: To defendant and defendant’s attorney of record; be advised that pursuant to **California Evidence Code Section 1108**, the People intend to introduce evidence of any prior act(s) of sexual offenses committed by the defendant.”

COUNT 11

On or about October 21, 2010, in the County of Mono, the crime of LEWD ACT UPON A CHILD, in violation of **PENAL CODE SECTION 288(c)(1)**, a Felony, was committed by JOSEPH THOMAS WALKER, who did willfully, unlawfully and lewdly commit a lewd and lascivious act upon and with the body of JANE DOE, DOB: 10/19/95, who was FIFTEEN years old, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the defendant, who was at least 10 years older than victim, to wit: Defendant had sexual intercourse with JANE DOE, DOB: 10/19/95, at his residence in Mammoth Lakes when his wife was out of town.

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.67**.

It is further alleged that a grant of probation shall be limited pursuant to **Penal Code Section 1203.67**.

On or about September 5, 2011, in the County of Santa Barbara, the crime of UNLAWFUL CONTACT WITH A CHILD WITH INTENT TO COMMIT A SEXUAL CRIME, in violation of **PENAL CODE SECTION 288.3**, a Felony, was committed by JOSEPH THOMAS WALKER, who did willfully and unlawfully contact or communicate with a minor, JANE DOE, DOB: 10/19/95, who knows or reasonably should know the person is a minor, with intent to commit Penal Code section 288(c)(1) – LEWD ACT ON A CHILD AGED 14 OR 15 YEARS OLD.

“NOTICE: To defendant and defendant’s attorney of record; be advised that pursuant to **California Evidence Code Section 1108**, the People intend to introduce evidence of any prior act(s) of sexual offenses committed by the defendant.”

SPEC ALLEG – SERIOUS/VIOLENT/REGISTERABLE SEX OFFENSE FELONY

It is further alleged as to all counts that the above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and/or a violent felony described in subdivision(s) of Penal Code section 667.5 and/or an offense requiring registration under the provisions Penal Code sections 290 et seq, pursuant to Penal Code section 1170(h), that the defendant is ineligible for a state prison sentence to be served in the county jail.


NOTICE: Pursuant to Penal Code section 1170(f), notwithstanding any other provisions of this section, for purposes of subdivision (h) of section 1170, any allegation that a defendant is ineligible for a state prison sentence to be served in the county jail due to a prior or current conviction, or sentence enhancement, or because he or she is required to register as a sex offender, or because the legislature specifically excluded the offense, shall not be subject to dismissal pursuant to §1385 PC.

“NOTICE: As to counts 1, 2, 3, 4, 5, 6, 7, 8, 11 and 19, pursuant to Penal Code section 784.7, it is agreed to by George Booth, the district attorney of Mono County, that such offenses that have been committed in Mono County by JOSEPH THOMAS WALKER involving JANE DOE, DOB: 10/19/95, may be prosecuted in Santa Barbara County.”

Pursuant to penal code section 1054.5(b), the people are hereby informally requesting that defense counsel provide discovery to the people as required by penal code section 1054.3.

I DECLARE UNDER PENALTY OF PERJURY THAT THE FOREGOING IS TRUE AND CORRECT AND THAT THIS COMPLAINT CONSISTS OF 21 COUNT(S).
